



Rules for Summer Preschool

During weeks 28-31, regular preschools and youth recreation centres are merged. Vänerparken Preschool 25, in the centre, provides childcare, and for children who have a placement in the Dalsland area, a placement at Frändefor Preschool is offered weeks 28-29 and at Brålanda Preschool weeks 30-31. The youth recreation centre in Tärnan provides childcare during weeks 28-31.

Children whose parents work or study during these weeks can apply for childcare. At the summer preschool/youth recreation centre, your child will meet children and educators from places other than the child's regular preschool/youth recreation centre. Regular childcare fees are charged.

Registration for Summer Preschool

Who can apply for a placement?

Guardians of children from eight years of age who have a placement in preschool/youth recreation centre can apply for childcare at summer preschool to the extent necessary for work or studies. If you need a placement during weeks 28-31, "Registration for summer childcare" must be filled out digitally. Childcare is offered to job-seeking guardians if a work certificate has been presented.

Public preschool and parental leave are not offered a placement at summer preschool/youth recreation centre. No introductions of children take place during weeks 28-31.

Registration

Vänersborg Municipality offers childcare at summer preschool/youth recreation centre provided that the "Registration for summer childcare" has been submitted by 31 May 2024. On the registration, enter the child's name, regular placement, guardians' information and other information that may be of interest to the preschool/youth recreation centre. **To be able to plan the activities, you must also submit the child's schedule times via the InfoMentor Hub app.**

Notification of placement

When the child has been given a placement in summer preschool/youth recreation centre, a placement notification is sent out to the guardians. The placement notification contains information about the summer activities, the department the child has been placed in and contact information for the department.

Notify the municipality's administrator for placements if there is no longer a need for a placement or the need has changed.

Schedule

The child's attendance times at the preschool/youth recreation centre must be registered via the InfoMentor Hub app.

- If the guardians work or study, the schedule must be based on work/study times including travel time.
- If the guardians are a short-notice substitute, the same guidelines apply as for those who work or study and the schedule is made based on working hours including travel time.

Absence and leave

Illness and other leave is reported via the InfoMentor Hub app or directly to the summer preschool/youth recreation centre.

Contact information for the preschool/youth recreation centre can be found in the placement notification sent out when there is a placement.

The child may not be in summer preschool when a guardian has a holiday or other time off (such as flextime, leave).

Activities at inconvenient working hours

Guardians who have childcare during inconvenient working hours use the same digital registration.
